Introduction

PUSPAC has completed 24 years of service by 2018. It is a matter of great pleasure and honor for PUSPAC and its members and staffs for their commitment and contribution in the field of health, education, livelihood and women empowerment. In the earlier stage, effort has been made to organize the rural tribal & Dalit poor through the organizational existing network member of CBOs in the target villages of Khairput Community Development Block of Malkangiri district. In the same stage, the work forces had been suffered a lot with factors as such lack of understanding to redress the issues, skill for sufficient effective display, Back ground of organization, personal qualities of members and lack of guidance. PUSPAC in its first interaction with the villagers of Govindpalli GP in Khairput Block was traced diverse problems that draw constant action to mitigate the problems through adequate management of local resources and the efforts are still going on. Interaction with the communities and specially the tribal villagers was not very encouraging but PUSPAC did not lose patience and hope. This backdrop has evolved organizations knowledge thereafter the activities of PUSPAC has been re-organized on due course of function. Since that time PUSPAC changes gradually in its structural position as a mature organization with human resource, programmatic changes, participation of local persons and support from different quarters. The organization started some good programme that based on Need Based approach and Right Based Approach.

The specific leadership in the organization was emerged confidently with the passage of social atmosphere where in, the same encourages voices of vulnerable from various invisible pockets of this locality. The hands of support for sustainable development were also raised in gradual course. After strenuous effort over the years, PUSPAC has nurtured multifold new dimension in its action and recognized itself by District Administration as premier and notable organization and in addition to that PUSPAC also have connection as active partner of various issue base state level networks. During these years of operation, PUSPAC has tried to maintain transparency at various levels both in its thought and action. This has helped in strengthening the rapport with its partner communities as well as donor partners. The policy making body of PUSPAC is conscious enough in its day to day activities and provides the required input to the concern workforce for well managed operation. By the end of year 1999, PUSPAC intended to have a re-look at its action and did a plan for next five years which focused upon initiating dialogue with the local level PRI members and this resulted to identify various programmes as well recognized the partner community from the most poorest section of the local society. During the starting of the current session PUSPAC has again made a long range plan till 2010 for both the organization as well as for the programme that to be implemented basing upon the guidance of Millennium Development Goal of UN General Council.

Vision: A self sustained and empowered Tribal society where everyone will have dignity in Malkangiri District by end of 2020.

Mission: "PUSPAC committed to empower People's Organization at the grass root level with sophisticated action in line with minimize the day to day problems and issues that perennially affected their life and livelihood through available local resources and equal facilitation".

Goal: PUSPAC would take care of community in organized manner and also facilitate social, economical & cultural development instruments. In fact the organization targeted that the community of Malkangiri District will access primary education, livelihood, Environment, health and sanitation as well free of food crisis by 2020.

- vi. To build up a strong social team through various efforts, where in the team will combat against any emergency situation.

- xi. To build up a society where some specific interaction will be promoted economic status of tribal on the develop the entrepreneurial habit among the tribal population. Through on-farm and off-farm ventures with ultimatum to address the Food security needs.
- xii. To build up an alliance with local & global agencies through various communication and coordination, where appreciation of such agency shall be brought towards the programme undertaken by the organization.
- xiii. To build up an extension interaction of the organization to study the issues of tribal and assimilates the database that to supplement the thought process of organization so that the organization can proceed in each programme through planned development action.

Legal Status

PUSPAC owes its origin to the urge of some dedicated youth to mainstream welfare schemes for community development through institutional process of established an organization. The organization was established in 1994. Over the years, the organization has undergone functional and operational dynamism and has grown into a leading Voluntary Organization in Malkangiri District. The organization is registered under Societies Registration Act 1860 and has subsequently been registered under FCRA in April 2000. In due recognition of its social service the organization has been able to get exemption under U/s 80G and 12 A of Indian Income Tax Act since 2006/07 and TAN as per the income tax Act 1961 by Aug 2016.

STRUCTURE AND MANAGEMENT

Both the General Body and the Executive Body look after activities of the organization under different programmes. The General Body meets at least once in a year to deliberate on organizational matters and to aid & advise the Executive Committee. The Executive Body consists of 7 members. The Executive Body is responsible for working out various strategies so as to help the organization realize its vision and adhere to its mission.

PUSPAC's field operations are organized under different projects in their respective areas. It has three wings; 1. Programme, 2. Finance & 3. Administration. The **Programme Wing** is supported Project Coordinators, Programme manager, and Gender coordinator, CSP, CRP and PRP. The **Finance Wing** is managed by Accounts Officer and the **Administration Wing** is supported by Administrative Officer.

These wings work in coordination with Core Committee of the Organization comprising of The Chief functionary of the Organization, Programme Coordinator, Accounts Officer and Administrative Officer. Programme Coordinator is the Convener of Core Committee. PUSPAC has Finance Committee and Gender Committee. Treasurer and Accounts Officer are the members of the **Finance Committee**. Gender Coordinator and all the female member of the organization are the members of the **Gender Committee**. Gender Coordinator is the Convener of the Committee.

The General Body meets at least once in a year, the Executive Committee at least twice in a year, the Core Committee, Gender Committee and Finance Committee at least once twice in a year. The Project Coordinators meet once every month to plan & review the progress of the projects.

PUSPAC has developed a system & procedure for monitoring and assessment of the impacts of its initiatives through holding meetings of its staffs. Project-wise monthly meetings are organized attended by the responsibility holders of the project and the chief functionary of the organization to discuss the progress and prepare the monthly plans.

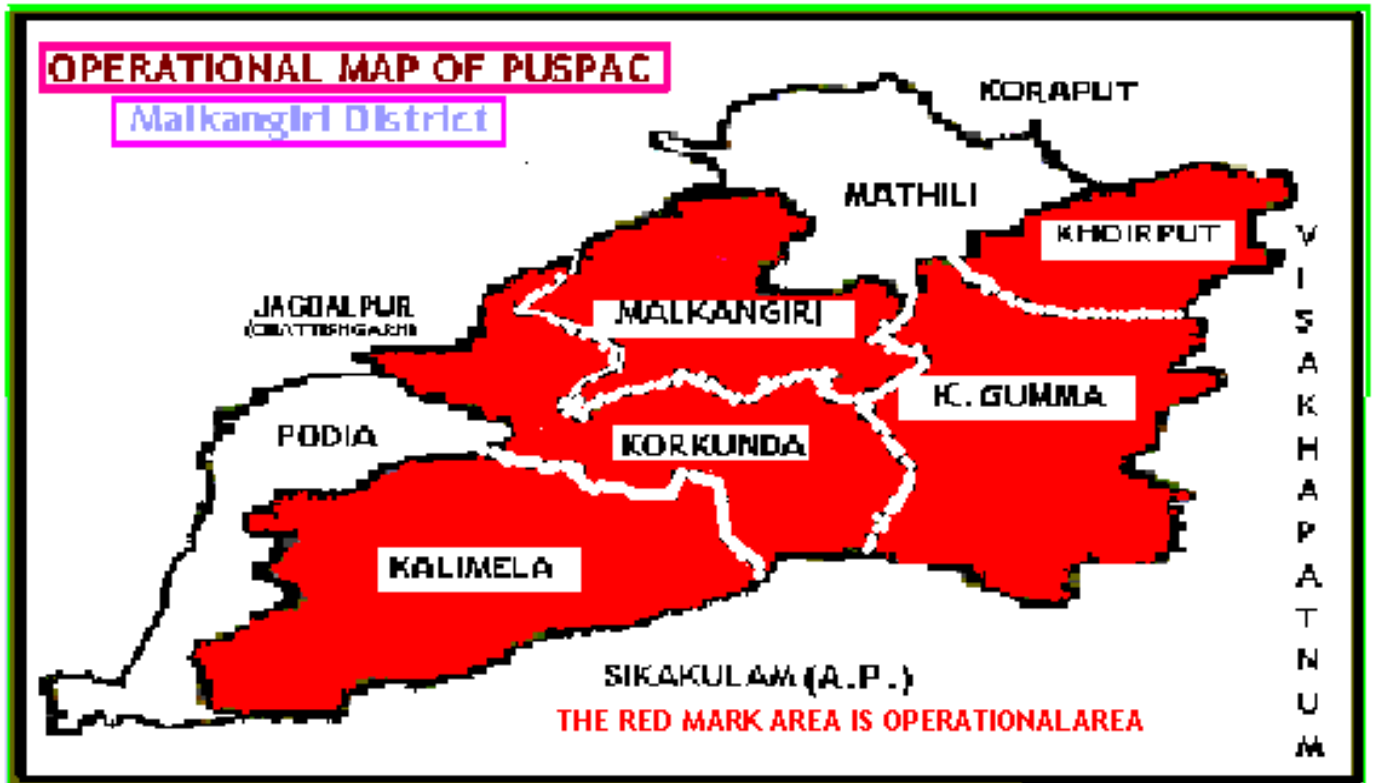

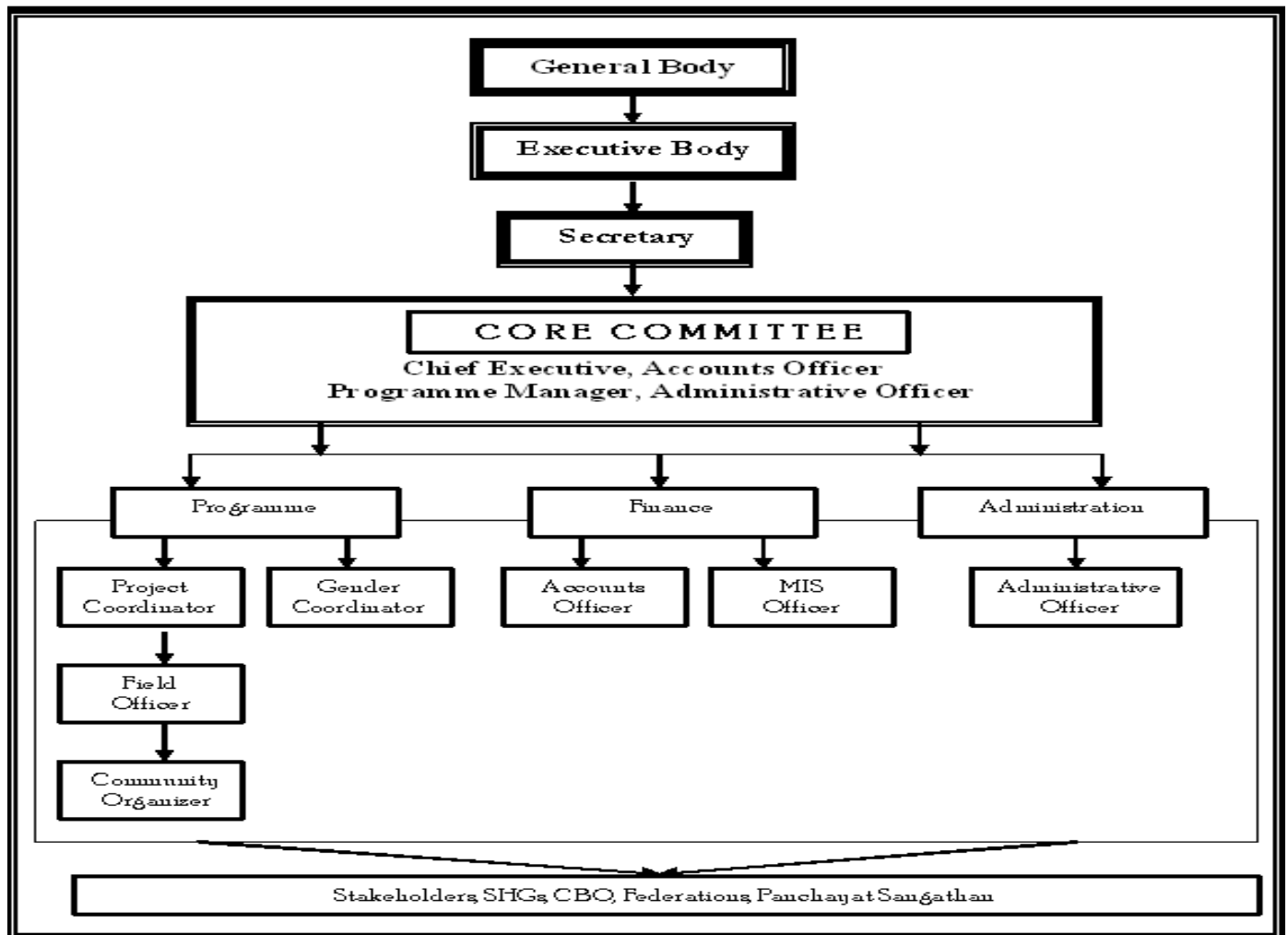

SWVGC (Strengthening Women Vegetable growers Cooperative)

1. Objective

With the overall objective to improve the quality of life of marginalized communities through livelihood focused through co-operative efforts and the specific objective of promoting and popularizing vegetable cultivation for economic benefits among 550 poor families covering 50 SHGs of 30 villages of 5 panchayats in Malkangiri (Padmagiri, Udupa, Serpalli, Pedakonda and Jharapalli GPs) blocks of Malakngiri district. PUSPAC has launched SWVGC with the support of AWO International, Germany through Madhyam Foundation, Bhubaneswar.

2. Activities -

- Sensitization training on social issues and Gender issues.
- Awareness programme on gender based discrimination practices.
- Training to SHG and cooperative members on various social security schemes and entitlement.
- Co-operative Management.
- Setting up vigilance committee and orientation.
- Facilitation support for linkage Govt. schemes for cooperatives.
- On farm orientation by CRP to vegetable growers.
- Training for vegetable growers on organic vegetable cultivation.

3. Registration of Cooperatives.

Training:



Following training programmes were conducted at different levels.

- 04nos field level training was organized for potential growers for promotion of Cooperative. 124 nos cooperative member was trained on cooperative promotion, management , record keeping, fund management, and Reg. of cooperative .
- 1 no. of district level training were organized for cooperative leaders on Cooperative management . 30 nos of cooperative member and 6nos of CEO were participated in this training.



- 04 nos training was organized at field level on social issues and Gender issues. 125 nos of cooperative members were trained in this training.
- 1no district level interface meeting was organized at zilla parisada conference hall. 110 nos vegetable growers and cooperative Leaders were participated and share their experience and problems. The line dept. was given solution of problems in the open discussion.
- 15 nos of sitting and orientation to vigilance committee members on social and gender issues, domestic violence, social security schemes, and monitoring of every govt. schemes. At the end session they are developed a model monitoring system at village level for better implementation the schemes.



Mahila Kishan Sashktikaran Parijyojana (MKSP)

PUSPAC NGO was implemented the MKSP project in 5 GPs of Malkangiri Block in Malkangiri District of Odisha, since July 2013 to onwards.

The main focus of the project- To ensure of food security of the women farmers, enhance household level income and promote strong Vibrant community based institution of women farmers for improving their collective bargaining power. For implementining this three Year project, NRLM, Govt. of India has sanctioned 75% of the Project cost and rest 25% support has been mobilized from Odisha Livelihood Mission, Government of Odisha. Madhyam Foundation, Bhubaneswar is co-coordinating agency which is the project Implementation with guidance and supervision of Odisha livelihood Mission, Government of Odisha.

Major Activities planned under the project:

- Promotion of SRI cultivation (550 women farmers) and vegetable cultivation (300 women farmers) through sustainable agriculture practices.
- Promotion of goat rearing among 50 landless women farmers.
- Strengthening the exiting women self help group in the project area, promoting 50 producer groups and collectivizing them in to 1 producer group & co-operative.
- Capacity building of women farmers on soil testing , soil health management, crop planning preparation & application of organic manures & pesticides, sustainable agriculture practices, management of producer group & co-operative.
- Providing drudgery reduction tools such as weeder & promoting zero energy cool chambers for interim storage of vegetables.
- Building a cadre of community resource persons (CRPs) for sustainability of project interventions.
- Facilitating convergence with exiting development schemes of the state government & central government.

AROGYA PLUS

Introduction

PUSPAC seeks to provide accessible, affordable, equitable and quality health care to the population in rural and inaccessible areas. In doing so, it has a focus on the Marginalized sections of society which tends to get excluded from the reach of the public health service delivery mechanism. This is so as the existing public health service infrastructure is poor in these areas because of which, it is not possible to provide the desired set of public health services. To bridge this gap in Infrastructure, various interventions such as Mobile Health Units (MHUs) have been introduced. In this background, it has been through for special strategy for delivery of a set of public health services in these inaccessible and conflict areas having strong presence of Left Wing Extremists (LWE). This strategy is being conceptualized as **Project Arogya** – successfully implemented on pilot basic in Mathili block under Malkangiri District.



Objectives:

- To provide primary, preventive, curative and primitive health care services and referral health services to the people in the designated area.
- To co-ordinate the district local public health system to achieve MMR and IMR etc.
- Prevention and control of communicable diseases.
- To build up the capacities of the GKS and establish community level monitoring system for effective management of the programme.

Maa Gruha (Maternity Waiting Home)

Back ground:

Geographical barrier and Lack of communication hinders transportation of expectant Mothers to hospital in the last stage of labour or in emergency. Suitable place & cost factors involved in staying outside before delivery is also not up to their reach because of their poor economic status. So, in spite of provision given under JSY, institutional delivery is not reported to have increased. These problems can be approached through establishing Maa Gruha (Maternity Waiting Home) especially for people living in most difficult pockets. In this context PUSPAC got a chance for implementation of Maa Gruha project in Mathili block under Malkangiri Dist. with the funding support of NHM, Malkangiri. Initially NHM Malkangiri gave project support for purchase of non recurring item.

Objectives:

- To establish alternative support infrastructure for addressing communication problems in difficult and inaccessible pockets for ensuring institutional delivery.
- To increase institutional delivery in the difficult and inaccessible pockets ultimately minimizing maternal & newborn mortality & morbidity.
- Maa Gruha it is a temporary home for expectant mothers where they can wait for safe delivery preferably 7 to 10 days before EDD. On onset of labour, they are to be shifted to nearby to nearby health facility having at least BeMOC facilities for delivery. No post-partum cases will be allowed to stay at this Home. Ideally it should be located nearer to the hospital.

Major activities-

- Community mobilization.
- Counseling to pregnant mothers about safe delivery
- Immunization, family planning, health & sanitation etc.



- Free transportation facility for pregnant mother.
- Regular health check-up.
- Health education sessions through IPC & Audiovisual aids.
- Act as client friendly environment & support.
- Submission of monthly & quarterly report time to time.

Key Deliverables:

- Under observation of pregnant mother before EDD.
- Ensure 100% institutional delivery of cases of refers to Maa Gruha.
- Minimization of unsafe & Home delivery in the project area.

Objectives:

The training of special category to make ASHAs has been planned to improve their efficiency in terms of knowledge and skills based on the needs of HBNC programme. The basic objectives of imparting training to ASHAs are follows

- Reinforcement of skills on HBNC to make competent for better performing.
- Find out the gaps on HBNC format fill up & reinforce the gaps.
- Update the knowledge on HBNC for counseling i.e. cares during pregnancy, delivery, care of newborn & postpartum mother.
- Be competent to identify the danger signs of newborn & post partum mother for timely referral to appropriate institution.

Achievements-

- Training on 6&7 module 4th round 11 batches conducted and 328 numbers of ASHAs participated.
- Training to special category of ASHA on HBNC 5 batch conducted and 158 numbers of ASHAs participated.
- Training of ASHA on population based screening on common Non-communicable diseases one batch conducted for 32 numbers of ASHAs.
