

## **Organizational Introduction**

PUSPAC has completed 29 years of service by 2023. It is a matter of great pleasure and honor for PUSPAC and its members and staffs for their commitment and contribution in the field of health, education, livelihood and women empowerment. In the earlier stage, effort has been made to organize the rural tribal & Dalit poor through the organizational existing network member of CBOs in the target villages of Khoirput, Korakunda, Malkangiri and Mathili Community Development Block of Malkangiri district. In the same stage, the work forces had been suffered a lot with factors as such lack of understanding to redress the issues, skill for sufficient effective display, Back ground of organization, personal qualities of members and lack of guidance. PUSPAC in its first interaction with the villagers of Govindpalli GP in Khoirput Block was traced diverse problems that draw constant action to mitigate the problems through adequate management of local resources and the efforts are still going on. Interaction with the communities and specially the tribal villagers was not very encouraging but PUSPAC did not lose patience and hope. This backdrop has evolved organizations knowledge thereafter the activities of PUSPAC has been re-organized on due course of function. Since that time PUSPAC changes gradually in its structural position as a mature organization with human resource, programmatic changes, participation of local persons and support from different quarters. The organization started some good programme that based on need Based approach and right Based Approach.

The specific leadership in the organization was emerged confidently with the passage of social atmosphere where in, the same encourages voices of vulnerable from various invisible pockets of this locality. The hands of support for sustainable development were also raised in gradual course. After strenuous effort over the years, PUSPAC has nurtured multifold new dimension in its action and recognized itself by District Administration as premier and notable organization and in addition to that PUSPAC also have connection as active partner of various issue base state level networks. During these years of operation, PUSPAC has tried to maintain transparency at various levels both in its thought and action. This has helped in strengthening the rapport with its partner communities as well as donor partners. The policy making body of PUSPAC is conscious enough in its day to day activities and provides the required input to the concern workforce for well managed operation. By the end of year 1999, PUSPAC intended to have a re-look at its action and did a plan for next five years which focused upon initiating dialogue with the local level PRI members and this resulted to identify various programmes as well recognized the partner community from the most poorest section of the local society. During the starting of the current session PUSPAC has again made a long range plan till 2030 for both the organization as well as for the programme that to be implemented basing upon the guidance of Millennium Development Goal of UN General Council.

**Vision:** A self sustained and empowered Tribal society where everyone will have dignity in Malkangiri District by end of 2030.

**Mission:** "PUSPAC committed to empower People's Organization at the grass root level with sophisticated action in line with minimize the day to day problems and issues that perennially affected their life and livelihood through available local resources and equal facilitation".

**Goal:** PUSPAC would take care of community in organized manner and also facilitate social, economical & cultural development instruments. In fact the organization targeted that the community of Malkangiri District will access primary education, livelihood, Environment, health and sanitation as well free of food crisis by 2030.

### **Specific Objective**

To builds up a society through schemes & innovative approach, where everyone shall have Health food, decent shelter in good habitants and access to basic education as well as to higher education leading to optimum human actualization and have access to quality health, sanitation & safe drinking water services.

- iii. - iv. To build up a society through innovative approaches where everyone will share the enjoyment from benefit of democratic governance system irrespective of caste, class, creed, religion, place of birth & culture.
- v. To build up a society through innovative approaches, where everyone shall have harmonious as well peaceful life & have access to fair justice of caste, class, creed, religion, place of birth & culture.
- vi. To build up a strong social team through various efforts, where in the team will combat against any emergency situation.
- vii. To build up a prosperous society through adoption of appropriate technological option, where industry, agriculture & other traditional livelihoods will flourish in harmonious manner and the same shall be committed to protect the original environment irrespective of nature, status and size.

- x. To build up a society where each interaction will be for development of quality leadership among the Tribal and especially among women and youth irrespective of class, creed, cultural heritage and identity.
- xi. To build up a society where some specific interaction will be promoted economic status of tribal on the develop the entrepreneurial habit among the tribal population. Through on-farm and off-farm ventures with ultimatum to address the Food security needs.
- xii. To build up an alliance with local & global agencies through various communication and coordination, where appreciation of such agency shall be brought towards the programme undertaken by the organization.
- xiii. To build up an extension interaction of the organization to study the issues of tribal and assimilates the database that to supplement the thought process of organization so that the organization can proceed in each programme through planned development action.

## Legal Status

PUSPAC owes its origin to the urge of some dedicated youth to mainstream welfare schemes for community development through institutional process of established an organization. The organization was established in 1994. Over the years, the organization has undergone functional and operational dynamism and has grown into a leading Voluntary Organization in Malkangiri District. The organization is registered under Societies Registration Act 1860 and has subsequently been registered under FCRA in April 2000 and registered for undertaking CSR activities and the Registration number is CSR00012323 on dated 30.07.2021 In due recognition of its social service the organization has been able to get exemption under U/s 80G and 12 A of Indian Income Tax Act since 2006/07. The organization is registered under GST REG-06 with Registration Number - 21AABTP1094J1ZO.

## STRUCTURE AND MANAGEMENT

Both the General Body and the Executive Body look after activities of the organization under different programmes. The General Body meets at least once in a year to deliberate on organizational matters and to aid & advise the Executive Committee. The Executive Body consists of 7 members. The Executive Body is responsible for working out various strategies so as to help the organization realize its vision and adhere to its mission.

PUSPAC's field operations are organized under different projects in their respective areas. It has three wings; 1. Programme, 2. Finance & 3. Administration. The **Programme Wing** is supported Project Coordinators, Programme manager, and Gender coordinator, CSP, CRP and PRP. The **Finance Wing** is managed by Accounts Officer and the **Administration Wing** is supported by Administrative Officer.

These wings work in coordination with Core Committee of the Organization comprising of The Chief functionary of the Organization, Programme Coordinator, Accounts Officer and Administrative Officer. Programme Coordinator is the Convener of Core Committee. PUSPAC has Finance Committee and Gender Committee. Treasurer and Accounts Officer are the members of the **Finance Committee**. Gender Coordinator and all the female member of the organization are the members of the **Gender Committee**. Gender Coordinator is the Convener of the Committee.

The General Body meets at least once in a year, the Executive Committee at least twice in a year, the Core Committee, Gender Committee and Finance Committee at least once twice in a year. The Project Coordinators meet once every month to plan & review the progress of the projects.

PUSPAC has developed a system & procedure for monitoring and assessment of the impacts of its initiatives through holding meetings of its staffs. Project-wise monthly meetings are organized attended by the responsibility holders of the project and the chief functionary of the organization to discuss the progress and prepare the monthly plans.

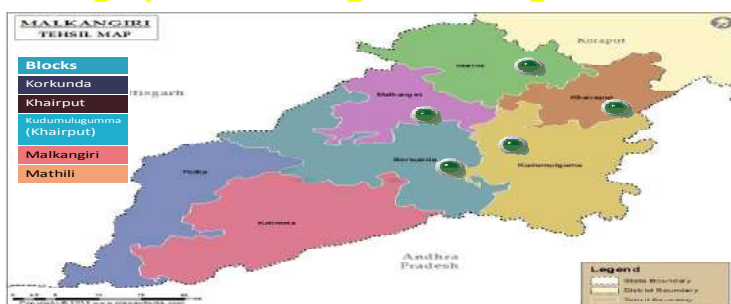

## Project at a glance Covid 19 Support Project-

More than the healthcare; this pandemic has adversely affected the socio-economic status of almost all the poor people in this economically backward district of Odisha. So, PUSPAC launch the integrated COVID-support project with financial support of Dasra.

This project covered all the six essential areas to make it truly integrated. The diagram given below has six components and thirteen results, impacts/achievements, of this one-year project. We shall discuss these in detail in this report.

1. This project played a significant role in saving the precious lives; especially among the poorest of the poor. The awareness generation activities, through social & behavioral change communications, helped the community residents to practice COVID Appropriate Behavior. The project also provided disinfection materials free of cost too many. Due to vaccine hesitancy and different unavoidable factors some people did not turn up for COVID-vaccination so we identified most of them and ensured their vaccination. Our care-packages were useful in enhancing immunity among the old men and women. And all these contributed towards saving lives in Mathili and Chitrakonda Blocks.
2. Although only for one year. November 2021 – October 2022, the project successfully protected the vulnerable people at the time of crisis as the pandemic disproportionately harmed the poor and aged. Our integrated approach in project was primarily pro-poor. We protected them though multiple ways like financial help, psycho-social support, etc.



3. Those were in need of help received all possible support from our project so we were able to address their requirements to certain extent.
4. Family Strengthening measures were needed specially to protect the children so most of our activities effectively contributed to this cause.
5. Our activities and family strengthening measures played an important role in preventing family-child separation; especially for the parent-less children or orphans.
6. This integrated project furthers the cause of social protection that was the need of the hour due to pandemic in this economically backward district.
7. Our awareness programs were very useful in transforming lives by building positive attitude and optimism as many were under tremendous mental pressure due to the multiple effects of pandemic like loss of income, loss of lives, uncertain future, etc.
8. The concept of holistic development is very important for a just and equitable society than addressing development in a piecemeal manner. Through our integrated approach and way of implementing the six-components of project we too strengthened holistic development.
9. The front-line workers like ASHA, ANM, Anganwadi team, Village Volunteers etc. are very important for the community and they will be there in a rather permanent manner to serve the people. So, through our training programs we were able to further improve their knowledge, attitude and skills required at community level while managing COVID-19.
10. People those live in hard-to-reach or difficult areas were also served by this project.
11. Skill is a prerequisite for survival of every individual. Without skill it's difficult to earn decently. The pandemic threatened the economic development and pushed the poor families further so through our skill development program we were able to support fifteen youths and adults by getting them enrolled in vocational training institutes like ITI.
12. All individuals are important for us but we cater more to the need of poor, vulnerable and those are less visible or reachable. The Dasra - PUSPAC project did everything possible to ensure that no one is left behind in development journey. Thus, the last man standing in the queue also received project's support that s/he deserves. This philosophy of project generates compassion and mission spirit as a result of which our team members ensured that no one is left behind; especially at the time of this crisis that the pandemic unfortunately brought for one and all.

Any disaster also brings some opportunity to make weak a strong person and the strong one stronger. Here in this project, we were able to contribute for building resilient communities thus when the next pandemic or wave comes all can face courageously.

## Activities -

### i. Awareness, Information & Counseling

In this one-year project we conducted 323 Awareness programs in 323 villages of Mathili and Chitrokonda blocks which benefited 8075 community residents. 5248-female and 2827-male actively participated in these programs. Most of them belong to the tribal communities.

## ii. Financial Assistance

Through emergency cash-transfer we supported seventy needy families across Malkangiri district who's earning members died during the first and second waves of pandemic. We obtained the list of eligible beneficiaries, given below, from the office of the Collector & District Magistrate, Malkangiri.

## iii. Infrastructure, Equipment & Medical support

1615 families of Mathili and Chittrakonda blocks were given essential kits and each packet had sanitizer, masks, IEC materials, etc. We demonstrated the use of these kits as well as hand washing techniques which helped many to practice proper hand-hygiene by using soap and sanitizer.

## iv. Training & Capacity Building

We conducted 30 capacity building programs and imparted training to 1445 people which also includes 50 Village Volunteers and several front-line-workers like ASHA, ANM, Anganwadi team, etc.

## v. Skilling & Livelihoods

Fifteen families of Mathili and Chitrokonda blocks were benefited through skilling & livelihoods. We identified 15 people in the age group of 25 – 50 from the families reported deaths during the pandemic period.

Seven beneficiaries were enrolled in different technical courses of the Government ITIs at Malkangiri and Mathili. After completing respective courses, they will be able to earn as there is a high demand of skilled manpower produced by the ITIs.

## vi. Care-Package

Through our care-package we were able to support 45 people of Mathili and Chitrokonda blocks. 23-women and 22-men were supported those recovered from COVID-19 .

## Primary Health Care

Public private partnership (PPP) has emerged as one of the important stages for health sector reform in Odisha. Initiatives have been taken by NHM and Health and Family welfare Dept. Govt. of Odisha to undertake different PPPs in meeting the growing needs for health services and of the national health programmes. With the Support of NHM, PUSPAC is managing a PHC(N) at Janbai Which is remote area of Malkangiri Dist.

## PHC (N) Janbai Project

The OPD is functioning 24x7 hours with alternative support of the Allopathic doctor, Ayush doctor and other staffs. Every day more than 32 patients from nearby villages are visiting to this hospital for

treatment. We also refer serious patients to SDH, Chitrakonda. We conducted regular monthly review meeting of all the Project staffs.

### SWASTHYA SAMPARK

#### Introduction

Providing comprehensive primary health care (CPHC) services at the door steps is one of the important objectives of health care system delivery. To enable to do that all health sub centers are being transformed into health wellness centre (HWC) under PHC(N) Janbai. The sub centre HWC is to serve as the first part of call to provide a range of primary health care services covering preventive, promotive, curative, rehabilitative and palliative care. It is also expected to focus on collective community level action to address public health issues and issues related social and environmental determinants of health by promoting social accountability and community feedback process for ensuring quality health care services as well as health promotion activity. Providing CPHC through HWC in difficult to reach areas still remains as challenge, needs all out efforts to address it.

Community holds the key to the success of any programme. The Jan Arogya Samiti (JAS) is being formed at the SCHWC level to serve as institutional platform to promote community participation in its management , governance and ensuring accountability with respect to provision of health care services and amenities. Strengthening JAS and promoting community engagement in the functioning of HWC is one of the priority areas to ensure effective functioning of HWC.

To provide basic health care services to the local community in hard to reach and vulnerable areas, PUSPAC has been given the responsibility of running the PHC (N) Janbai in partnership mode. This PHC are mostly located in difficult area of the Malkangiri of Odisha state which needs special attention.

It is intended to accelerate community engagement in the functioning of HWC, strengthen community based platform, community level groups and thereby maximize delivery of health services and promote health and wellness among people.

#### **OBJECTIVE of the Programme:**

- Promote community support ecosystem for the effective functioning of SCHWC.
- Accelerate community involvement and action in the implementation of health and wellness activities.

#### **ACTIVITIES:**

#### **AROGYA PLUS (MHU)**

#### **Introduction**

To address the health issues of the vulnerable groups, especially the mobile population by providing preventive and curative health care services at their doorsteps on routine manner and thereby creating an enabling environment through social mobilization for improved health seeking behavior towards public health , one Mobile Health Unit (MHU) is running since Jan 2015 in the remote areas of Mathili Block by PUSPAC with the support of National Health Mission (NHM) Its covers 88 villages 6 GP of Mathili Block. Near about 25,000 populations covered.

To bridge this gap in infrastructure, various interventions such as Mobile Health Units ( MHUs ) have been introduced.

In this background, it has been through for special strategy for delivery of a set of public health services in these inaccessible and conflict areas having strong presence of Left Wing Extremists (LWE ). This strategy is being conceptualized as **Project Arogya** – successfully implemented on pilot basis in Salimi of Mathili block under Malkangiri District.

#### **Objectives:**

- To provide primary, preventive, curative and primitive health care services and referral health services to the people in the designated area.
- To co-ordinate the district local public health system to achieve MMR and IMR etc.
- Prevention and control of communicable diseases.
- To build up the capacities of the GKS and establish community level monitoring system for effective management of the programme.

## Maa Gruha (Maternity Waiting Home)

**Back ground:** Geographical barrier and Lack of communication hinders transportation of expectant Mothers to hospital in the last stage of labour or in emergency. Suitable place & cost factors involved in staying outside before delivery is also not up to their reach because of their poor economic status. So, in spite of provision given under JSY, institutional delivery is not reported to have increased. These problems can be approached through establishing Maa Gruha (Maternity Waiting Home) especially for people living in most difficult pockets. In this context PUSPAC got a chance for implementation of Maa Gruha project in Mathili block and Chitrakonda block under Malkangiri Dist. with the funding support of NHM, Malkangiri.

## Objectives:

- To establish alternative support infrastructure for addressing communication problems in difficult and inaccessible pockets for ensuring institutional delivery.
- To increase institutional delivery in the difficult and inaccessible pockets ultimately minimizing maternal & newborn mortality & morbidity.
- Maa Gruha it is a temporary home for expectant mothers where they can wait for safe delivery preferably 7 to 10 days before EDD. On onset of labour, they are to be shifted to nearby to nearby health facility having at least BeMOC facilities for delivery. No post-partum cases will be allowed to stay at this Home. It was located within campus of Mathili CHC and chitrakonda CHC.

## Major activities-

- Community mobilization through village meeting and stake holder meeting
- Counseling to pregnant mothers about safe delivery, immunization, family planning, health, Nutrition & sanitation etc.
- Free transportation facility for pregnant mother.
- Regular health check-up.
- Health education sessions through IPC & Audiovisual aids.
- Act as client friendly environment & support.
- Submission of monthly & quarterly report in time to time.
- Attend VHND, Immunization camp, Review Meeting and sector meeting.
- Home Visit by staffs

## Key Deliverables:

- Under observation of pregnant mother before EDD.
- Ensure 100% institutional delivery of cases of refers to Maa Gruha.
- Minimization of unsafe & Home delivery in the project area.

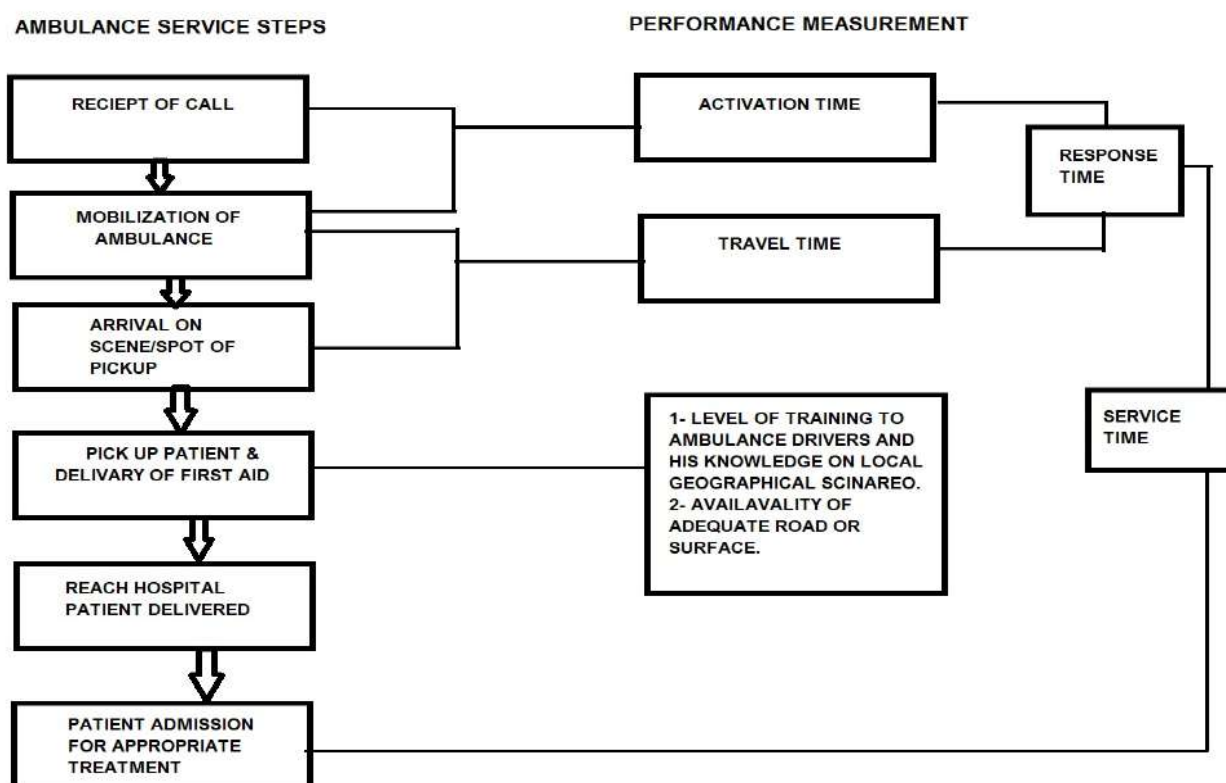

**Introduction-** The multipurpose cyclone/Flood shelter has constructed at Dhungiaput G.P head quarter by Govt. of Odisha/OSDMA to provide safe shelter to the vulnerable people during the time of disasters/Emergency extreme events and its shelter already handover to the community /village for management and maintenance. Now the ownership of the MCS and MFS is purely lying with the community /villages in general and a community based organization; Cyclone /Flood shelter management and maintenance committee in particulars.

One day Mock drill exercise on Disaster preparedness on dated 19.06.2022 organized by OSDMA /Dist. Administration/MFS, Dhungiaput, Mathili, Malkangiri where is 70 above selected participants were present. At first Addl. Tahasildar , Mathili welcomed all the participants. Then Addl. Tahasildar ,Mathili shared the **objectives of the MFS**, Dhungiaput with the participants. Such as;

- To review the emergency preparedness plan of the organization and evaluate standard operating procedure so that concerned person s would deliver their duties effectively while keeping in cognizes of life and property.
- Mock drill is arranged on disaster of fire in various schools by fire fighters. It includes the demonstrations like extinguishing the fire rescuing the people trapped at higher floods of buildings, rescuing the persons whose clothes are on fire.
- In simple understanding mock drill is a practice as how to save life in real time situation of any kind of danger calamity that occurs with no advance or very little time to evacuate from place. Mostly helps when earthquake, sudden fire or building collapse.
- Mock drill helps employee too react quickly and safely as soon as during emergency crisis. This plays a vital role in health and safety and it is strongly recommended for all organizations.

**Types of Mock Drill-**The most common Take-5 drills are the standard fire drill, Communication drill, and first aid drill. Each of these requires more in depth explanations.

**Mock drill for Earthquake-**Mock fire drills and evacuation drills were executed for the entire school to create awareness and preparedness during calamities.

**Periodicity-** Mock drills have to be conducted one in every quarter either during day or night. Mock drills conducted frequently or drills at least once in every 3 months for existing buildings and for new buildings during the first 2years after the issuance of the certificate of occupancy. There after fire and emergency drills shall be conducted once in every 6 months.

**Procure of Fire Drill-** In event of a fire go immediately to the nearest fire alarm pull station and sound the alarm by pulling down on the lever. Fire drills should be carried out at least twice a year although this can vary if your fire risk assessment has outlined otherwise.

**Fire Drill-** A practice drill in extinguishing fires or in the conduct and manner of exit in case of fire. Mock drill exercise developed should be flexible and planned in accordance with the needs of concerned organization.

Mock drill is a completely demonstration of how to react whenever a disaster occurs. It identifies potential errors and risk. Improves coordination between different disaster control dept. It shows how to rescue and save people trapped or high floors, buildings.

**Purpose of Conducting Drills-** A fire drill is a simulation of evacuation that helps prepare participants for an emergency situation. After speech of Addl. Tahasildar , Mathili Mr. Basanta

Kumar Lenka honorable Secretary PUSPAC, Malkangiri also shared his valuable experience and concern topics with the participants.

Mr. Lenka described his experiences in the process of use and maintenance of multipurpose cyclone / Flood shelter. All the assets have been taken for the use of the social function of villagers with fixed rent.

**Record Verification-** Mr. Basanta Kumar Lenka, honorable Secretary PUSPAC, Malkangiri verified all records of multipurpose cyclone/Flood shelter, Dhungiaput and given suggestion for improvement.

### **Rescue team (Fire Department)**

The Addl. Tahasildar instructed fire officer, Mathili to share his experience about the mock drill exercise. The fire officer has elaborated about the rescue process and demonstrations have been made at multipurpose cyclone/Flood shelter at Dhungiaput. Then demonstration done by Fire department like Fireman lift, Pick back, chain nut, life boy and life jacket. Use of Base light, Aska Light, Generator and fire machine.

**New Committee formation-** The new committee constituted by the community under the chairmanship of local new Sarapanch as president taking 51 members. The member of multipurpose cyclone/Flood shelter had identified by the president and vice president in consultation with the villagers. Unanimously resolved by committee a joint bank account would be open in nearest bank to the shelter village in the name of President and Secretary like Bank of India, Govindpalli Branch. Joint Signatory name is :

**President** - Madhusudan Nayak- Sarapanch, Dhungiaput

**Secretary** - Tulasiram Majhi

The Existing bank account will continue in case of reformation or restructuring of the multipurpose cyclone/Flood shelter only the change of signatories if required.

**Vote of Thanks:** Mr. Makaranda Sahoo Programme Manager, PUSPAC had offered vote of thanks to all participants for orienting and demonstration on mock drill exercise in front of public. He had hoped that the members will implement the knowledge in their lives for better standard of living & smooth functioning of the multipurpose cyclone/Flood shelter.
