CONSTITUTION OF (P U S P A C.)



1. Definition:- The Institution/Organisation shall be called PEOPLE'S UNITED FOR SOCIAL PARTICIPATION AND AWARENESS CENTRE.(P U S P A C).
2. Address:- It is located in Village: G.Palli PO: G.Palli P.S. G.Palli . Dist. Malkangiri.
3. Membership:- Irrespective of caste, creed, poor or rich desirous of betterment of Society (age 20 to 45) eligible for membership. They should seat together and decide entrance fees.

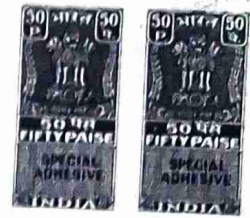

Cessation of Membership:-



- i) By resignation.
- ii) Permanently transferred from the locality or marriage (only for female candidate).
- iii) Death or physical unfit to attend the function having been attacked by fatal diseases.
- iv) Do any mischievous work to hamper the rules and regulation of the organisation can be impeached.

Impeachment:- By giving 2/3rd majority decision of the total members ~~an~~ a member can be impeached/dismissed from his seat.

Directive Body:- Annual general body meeting will be held in the month of October or May. The Secretary of the Organisation i.e. PUSPAC will prepare the annual report and read out it in the meeting. The General Body will nominate the Managing Committee for the next year.

The members elected in general body meeting to manage society will be the Directive Body.

Managing Committee:-

It will consist of members as may be decided in the general body meeting of the P U S P A C concerned. The members so selected will nominate the Chairman and Secretary and Treasurer. The committee will seat every month. The Secretary will be incharge of office and maintainance of cash book and all other registers prescribed by C.D. and R.R. Department.

Emergency Meeting:-

It shall be convened by Chairman/Secretary on requisition of 7(seven) member of the P U S P A C on occurrence of any emergency.

Quorum:-

1/4th of members shall form a quorum in all meetings. In case of quorum not being presented one hour of time appointed for the meeting, the meeting shall stand adjourned.

Notice:-

Notice of any meeting should be served before one week or the commencement of the meeting emergency meeting may be called by serving 24(Twenty four) hours notice.

POWER AND FUNCTIONS OF THE GOVERNING BODY MEMBERS:

CHAIRMAN:-

The elected Chairman will conduct all meetings. In her absence Secretary or any member as may be decided by the members will preside over a particular meeting.

VICE CHAIRMAN:-

She will be empowered to do Chairman's work at the time of Chairman absent in meetings.

SECRETARY:-

He should be an educated man of the village and will remain in the charge of the office and execute all programmes of P U S P A C and deal with all administrative matters within the general body meeting so presented by the Secretary.

TREASURER:-

She is the custodian of Organisation's cash and maintain all type of account work of P U S P A C.

FUNDS:-

- i) Subscriptions.
- ii) Donations.
- iii) Grant-in-aid from the Govt.
- iv) Indian Council of Child Welfare.
- v) Foreign aids.

VOTE:-

Every member has right to vote. The Chairman shall have casting ~~man~~ vote.

AUDIT:-

The funds of our organisation shall be audited annually by the Government Auditor or any qualified Auditors.

GENERAL:-

The Managing Committee reserves the rights to cancel the membership of the member is found guilty of breach of rules and regulations of the Organisation. The General Body has the right to amend the rules for better administration of the P U S P A C.

On abolition of the P U S P A C the property that remains after satisfaction of its liabilities will be given to the Panchayat Samiti concerned. This rule will be binding upon every members, of the P U S P A C.
